Programmes and Online Programmes) Regulations, 2020 (including its amendments from time to time).

12. That the Higher Educational Institution shall ensure not to enrol any learner without mandatory DEB ID under Online mode.
13. That the Higher Educational Institution shall submit student admission details through integration of HEI's admission portal with the UGC within the stipulated time as notified by the Commission from time to time.

That the Higher Educational Institution ensures the requisite number of full-time dedicated teachers exclusively for online mode and other administrative and technical staff is appointed as stipulated under Annexure-IV of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 (including its amendments from time to time).
18. That the Higher Educational Institution ensures to conduct proctored examinations with all the security arrangements ensuring transparency and credibility of the examinations.
19. That the Higher Educational Institution ensures to provide the details of all international learners enrolled immediately after the beginning of the academic session to the Ministry of External Affairs, Ministry of Education and University Grants Commission.

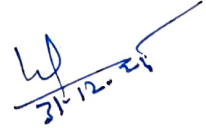

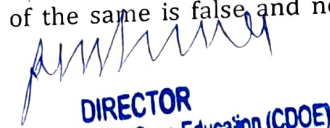
