2. **Compliance of UGC (ODL Programme and Online Programmes) Regulations, 2020 as per affidavit submitted.**
3. **Compliance of deficiency Communicated.**
4. **Representation received by HEI against the earlier decision of 'Not found Complied.'**

Remarks:
